Activities, conferences, and committee meetings will be scheduled with flexibility to provide increased opportunity for parent and family engagement.

Políticas de participación de Padres y Familias de la Escuela Majestic

Al apoyar y fortalecer el rendimiento académico de los estudiantes, la Escuela Majestic brindará oportunidades para aumentar la participación de los padres y las familias.
